- We always do our best to make sure your holiday arrangements are satisfactory and we accept liability for but only to the extent if as you as a result of our gross employees. However, we cannot accept the acts, omissions or deficiencies, of those principals participating with your holiday pursuant to ourselves and yourself (which the issue of a ticket, voucher whom we have no direct control. We do not accept any liability for injury, damage, loss, delay inconvenience caused directly majeure or other events which including but not limited to hurricanes, floods, unusually severe weather Government or any authority machinery or equipment,
