- We always do our best to make all arrangements satisfactory but only to the extent it is reasonable for you as a result of our good faith efforts. However, we cannot accept liability for any injury, damage, loss, delay, inconvenience caused by major events including but not limited to floods, unusually severe weather, Government or any other authority, or any other machinery or equipment.
- Except where otherwise stated, a deposit is due within 7 days of booking confirmation. The balance of the total cost is due upon arrival in Panama City. (or such later date as shall be specified in writing by the company).
