- We always do our best to make sure your holiday arrangements are satisfactory and we are not responsible but only to the extent you as a result of our employees, However, we cannot be held liable for the acts, omissions or errors, of those principals with your holiday purchases and yourself (with the issue of a ticket, voidable by whom we have no direct liability. We do not accept any liability for injury, damage, loss, delay or inconvenience caused by major events including but not limited to hurricanes, unusually severe weather, Government or any authority, machinery or equipment.
